The meeting was opened at 19:03

1. To consider accepting apologies for absence

No apologies were received.

2. To record declarations of interest from members in any items on the agenda

There were no declarations of interest.

3. To approve the minutes of the last Parish Council Meeting held on Monday 7 July 2025

The minutes had been circulated to all councillors prior to the meeting. Cllr. Ford proposed they be accepted, Cllr. Buckland seconded the proposal and councillors voted with a show of hands. The minutes were duly signed by the Chair, Cllr. Philip Leslie.

4. To discuss any matters arising from the minutes (7 July 2025) not on the agenda.

There were no matters arising.

5. To adjourn the meeting for public participation, an opportunity for members of the public to raise any queries and concerns.

A member of the public mentioned an agenda item in the minutes on the website was wrongly numbered. The Clerk confirmed this had been previously corrected and the minutes just signed by the Chair were correct. Minutes on the website would be updated with the corrected version.

6. To discuss NCC – Invitation to bid for Parish Partnership grant for 2026/2027

The Clerk had emailed Matt Lines of NCC Highways to obtain a quote for part time 20mph signs with flashing warning lights for installation outside the school, listed as an acceptable item for this grant. Waiting to hear back. The Clerk had also emailed County Councillor Ed Connolly (EC) to gain his support for the project and to see if he would be able to contribute at all from his member's fund. **Post meeting note:** EC replied that his highways allowance has been fully utilised for the financial year, but he confirmed he was in support of our request. Emailed Matt Lines again 12/9/2025.

Cllr. Swaddling said, because the school is approached from three directions, three flashing signs would be needed.

7. To update on Breckland's Local Plan (RH)

A public meeting was held in the Village Hall on Saturday 12 July, to explain the outcome of the repeated 'Call for Sites' exercise, and get feedback from residents so that we could better represent them. The meeting was attended by over forty residents, and all speaking expressed strong objections to all of the proposed development sites. Subsequently, on 17 July, Rocklands Parish Council (RPC) sent a comprehensive representation to Breckland Council – robustly objecting to all of the development sites which had been submitted.

The next stage is the (repeated) formal consultation on 'Preferred Sites' – which should commence in October. RPC will again hold a public meeting before submitting representations on behalf of residents.

8. Speeding: To update on SID (flashing speed sign) (RH)

RH apologised that the speeding data had not been analysed in time for this meeting but would be provided in time to be included in the minutes (See below and tables at end of minutes).

In the last period, the speed sign was deployed as follows:

The Street - Vehicles Approaching Village Hall from Crossroads

Deployed: 14:00 hrs 03 July 2025

Finished: 10:00 hrs 12 August 2025

The analysis results show:

14,084 vehicles detected

Average 354 vehicles/day

Morning peak time - 08:00 to 09:00

Afternoon peak time - 17:00 to 18:00

10,269 vehicles (72.9%) within **30 mph** speed limit

3,815 vehicles (27.1%) exceeding speed limit

- of which 803 vehicles (5.7%) over 35 mph - and likely open to a fine*

Top speed: **55 mph** - 15/07/2025*

Note that, for this period, the speed sign was deployed for much longer than usual - due to my time constraints.

Since the last deployment monitoring traffic approaching the crossroads from the Village:

- vehicle movements averaged 354 per day - a 10.0% decrease in daily traffic volumes.
- vehicles speeding numbered 3,815 (27.1%) - a 7.5% increase in the proportion of vehicles speeding.
- vehicles open to enforcement action numbered 803 (5.7%) - a 2.3% increase in vehicles open to enforcement.

*Note that 2 vehicles were recorded travelling at 55 mph during this period.

The increases in vehicles speeding, and open to enforcement, whilst traffic volumes decreased is wholly unacceptable - and this on a village street with no pavement.

Cllr Tim Ford and I moved the speed sign to monitor traffic on The Street approaching the B1077 crossroads from the village, on 12 August.

As always, I am indebted to Tim for his continued support.

Cllr. Ford agreed to take on the collection and analysis of data in the future. Thank you to Cllr. Ford.

It was reported that school coaches had been seen speeding on the bend in Rockland. AJB to confirm company name and number plate if possible. Letter of complaint to be written to the coach company.

9. To update on Flooding and Rockland's Flood Group.(RH)

We have yet to arrange a meeting between the landowners holding the key parcels of land which offer the most significant mitigation opportunity, ourselves, and representatives of the LLFA.

10. To discuss Chapel Green Wildflower Meadow (CS - conservation biologist)

CS summarised the situation. The meadow is Parish Council Land and is a Community Asset. Although the land area equates to just 0.03 hectare it requires a lot of hard work to maintain this small area. A grant was received in the millennium 2000 for regeneration of the area, to manage the meadow and the pond.

In 2017 the meadow was discussed and it was agreed the area should be maintained as a Wildflower Meadow. A management committee was formed. There is an annual cut, that was originally done by the Bacon Family but they have now moved out of the village. Paths are mown into the meadow for visitor to view the wildflowers, the pond and the wildlife. The area is a huge sponge, taking up water and supports a huge and important biodiversity. An NCC grant of £7000 was used to clear out the ponds and maintain the edges from falling in. This is village Heritage and is famous in East Anglia. There is a book that has a chapter on moths found at the Rockland Meadow.

There are two permissive ways that allow residents access to the houses to the side and behind the area. There has been a gradual encroachment of the area by residents. This has caused much conflict and animosity over the years. Sometimes resulting in physical violence and involvement of the police. There are areas that cannot currently be mowed as spoil has been deposited by residents.

The Parish Council agreed they do not want to see any encroachment of this area but also do not want to inflame the situation to a level that has been experienced in the past with several individuals. Parish Council agreed to proceed cautiously.

11. To discuss the Rocklander (Karen Roseberry KR)

Karen Roseberry (editor of the Rocklander) was present at this meeting to discuss the email sent to the Parish Council asking for financial support.

It's coming to the point where we are struggling to cover the cost of the print of the Rocklander magazine. Each issue costs just under £1 to print and the advertising has dwindled over the last year. I recall Maureen having negotiated a contribution from the Parish Council as the magazine is used to circulate PC information and is a valuable village asset. And not to be forgotten it also comes under the remit of the shop which enhances their ability to win grants etc. Since the first year that we took it over the magazine has had no further contributions. I would be very grateful if you could discuss this with the PC members soon.

The clerk confirmed the PC had made a one-off contribution of £200 towards production of the Rocklander in the 2022-2023 financial year.

The chair said that a request for funds would normally be backed up by evidence of Income and Expenditure in order for the PC to make any decision. KR did have some figures with her and would submit these to the PC for discussion after the meeting.

The magazine was originally in Black and White. It takes 2 days per month to produce. Costs £290 per month for printing (£3480 per annum). KR has tried shopping around for a better price. Adverts generate ~£1580 per annum. Chris Riddell has donated £1000 plus other donations.

12. To receive District Councillor/County Councillor reports.

No reports were received prior to the meeting.

13. To receive news from village organisations and churches

Little Rocky's (Sharon Brown)

- We have had some incredibly busy summer sessions with so many very well-behaved children. We welcomed back our veteran siblings who have grown into confident little people. It only rained one Friday out of all the summer sessions, so we were jolly lucky. The children have spent many happy hours playing in our outdoor learning environment.
- Sadly, our summer sessions had to be cut short by one week as so many of our families were affected by a very nasty tummy bug. 8 children and one adult (to our knowledge) were struck down by this 'bug.' We decided to close a week early so we could do a deep clean. This has taken much longer than anticipated and we need to remain closed for a further week. We will re-open Friday 12th September.
- As we have been sterilising all our equipment, it was a golden opportunity to re-organise our resources cupboard. Thanks to our construction manager and his inventive ways of repurposing some donated palettes; we now have ample shelf space to store away all our equipment without it becoming a complicated Jenga construction, each week. It has also minimised the risk of things falling on us as we empty the cupboard.
- We will be updating our registration forms to remind parents not to attend sessions if their children appear to be unwell. We will also be reinforcing the 48-hour exclusion rule. We cannot afford to have a similar incident; we have so many vulnerable little people.
- Two of our mummies have had newborn babies and we look forward to welcoming them into the Little Rocky's Family.
- We have calculated that we will be losing in excess of 12 children at the end of this academic year. We have so many rising 4s who will all start school in September 2026. We may have to launch an advertising campaign to augment our numbers. This campaign is already on our agenda although we have had a dip in numbers before and still bounced back, so fingers crossed.

St. Peter's Church (John Brown)

- Success of the VJ service at the Memorial Bed with nearly 50 people attending.
- These outdoor services are proving to be more popular within the village than people wanting to actually attend a church service.
- The Remembrance Service will be held at the Memorial Bed on 9 November at 10.45 am followed by hot soup and a roll at the village hall.
- We have another display of Rocklands School artwork at St. Peter's showing again our commitment to community cohesion.
- We had a very successful day with the Chris Riddell portrait drawing appointments with people travelling all over the country to come to our village. It certainly put Rocklands on the map. So many visitors went up to St. Peter's Church to view Chris' drawings in our Portaloo and left wonderful comments in the visitor's book.
- 5 October - Harvest Service 10.30 at the Church - with produce.

Rocklands Village Hall (James Alger, Chair)

JA provided a report which was delivered by the Clerk.

Since the last council meeting Anglian Water have fixed the water leak near the road and the planned boxing in of the stench pipe has been carried out. We are still working on installing an extractor fan in the kitchen and repairing/resurfacing the entrance and car park.

Although the committee is hard working and enthusiastic we could do with more members to help spread the load, same situation for a lot of Village organisations.

The hall continues to be well used and we have had some new regular hirers which will help our finances and hope to be able to apply and be successful with grant funding in order to make further improvements. In addition to our regular hirers we have hosted a number of well attended community events such as the Strawberry Tea, Chris Riddell drawing session & VJ day.

All Saints Church (CJ)

This report from CJ was not received in time for the meeting but it was agreed it would be included in the minutes. Fortunately, we have had no more incidents of vandalism at the church since a large stone was thrown through the stained-glass window in May. The PCC is currently deciding whether to limit repairs to the broken panel which is covered by insurance or do repairs to the whole window to safeguard it for the future which would be very costly and are not covered! We have been very grateful to receive donations towards the cost from some villagers and offers of fundraising help from others, including Voice Junction who would like to do a concert to raise some money for the window. It may also be wise to get a guard to cover it, in case of further vandalism. Big decisions to be made.....

We have our Pets/Harvest Thanksgiving celebration later this month on 21 September at 10.30. This is always popular and is held outside, weather permitting. Pets of all shapes and sizes come along, with well-behaved owners (also of various shapes and sizes!) and a good time is had by all at a very informal service. Donations of food for the local Food Bank are welcome and the collection will be given, as always, to the local Food Bank.

The Harvest Supper is to be held later than usual this year and will be on 8 November in the Village Hall with the usual format of a lovely home-cooked meal, entertainment by the Roskettes and a good chat generally! Please look out for tickets when they become available nearer the time.

Things are progressing slowly with the amalgamation of the benefices of Shellrock and Hingham with High Oak and we are all doing our best to support Rev Tori as she tries to look after all twelve churches. Rev. Sue has now retired but is still around to offer advice, for which we are very grateful. As far as I know, there is no name for the new big Benefice, so any ideas will be welcomed, I am sure.

More news hopefully by next RPC meeting when details of Christmas events will be available !

14. To discuss Parish website and computer/laptop

The Clerk had made enquiries for another Parish Council for a replacement laptop for PC use and a new website. The information provided had been circulated to Rockland councillors for interest as they too were considering a new website. Cllr. Leslie had been looking for quotes too. The Clerk confirmed she is happy using her own computer for Rockland PC as she has always done. But it does make it easier to hand over a device and data should there be a change of Clerk. A quote for refurbished machine had been received from RLS Computer Services and also a quote for a new website. This information had also been circulated to Ian Scholes who maintains the Parish website.

There are new rules for .gov.uk websites and email address for Parish Councils and a need to consider security of data and GDPR. To be discussed further. Cllr. Leslie thought data may be able to be accessed remotely. For further discussion.

Parish computer/laptop. The Clerk has recently received a quote for Thompson Parish Council for a new computer as their laptop is very old and now not working properly. The Clerk had circulated this information to all Parish Councillors in case it was of interest to Rocklands PC. The quote is for £399 for a refurbished HP device with some extra costs for software and backup.

15 To report on Financial Matters

15.1 National Salary Awards from April 2025 to April 2026 - to agree Clerk's annual pay rise.

National Salary Awards, although very late again have now been agreed and published. Pay is therefore backdated to April 2025.

Level **SCP18** was £15.84 per hour from 1/4/2024. New hourly rate from 1/4/2025 is £16.35 (A 51p per hour increase. **£16.35** x 5 hours per week, x 52 weeks per year. Is £4251 / 12 months = **£354.25 per month** (Increase of £11.05 per month). Back pay due from 1 April 2025 to date (5 months) is therefore **£55.25**. The Clerk had circulated these calculations to the Chair prior to the meeting, for him to check and agree, which he did. Direct Transfer set up for back pay due and the standing order with Barclays to be amended to the new monthly figure of **£354.25** in time for 1 October 2025 standing order payment.

NPower electricity account for Streetlighting.

Npower, invoicing on hold since March 2025 due to NPower updating their computer systems and quoted (P344 ?) for Unmetered Supply customers. Have asked for our tariff to be looked at as our monthly payments have 'crept' up to an unacceptable level. Still no further invoices received

Rocklander (See agenda item 11)

Editor of the Rocklander, Karen Rosebery, has highlighted that the Rocklander is struggling financially. The PC made a one-off contribution of £200 in 2022/2023 financial year. Various options to consider. Reduce printing costs (it is very glossy). Remove print costs by distributing 'soft copies' Facebook, link, PC website. Increase advertising/advertising rates to cover production costs. Charge residents to purchase a copy hard copy or soft copy.

Parish Website and computer/laptop (See agenda item 14)

Parish Website. Ian Scholes and Philip had been discussing the Rocklands Parish website.

The Clerk had spoken with Kevin Bacon (ex NALC, now RLS Computer Services) on behalf of Thompson Parish Council. Their website is very old and messy and looks unprofessional. The person that maintains it is now elderly and is concerned about its maintenance in the future. Therefore, the Clerk was asked to look at the cost of a new website. The link to the RLS website is: [Website & Email Services - RLS Computer Services](#). RLS would set up a new website - transfer all data across from old website (in about 3 weeks !). The old and new can run independently from each other until ready to switch. The website would be [gov.uk](#). Emails would also be [gov.uk](#) and provided as part of the 'package'. New councillors joining would be provided with email addresses at no extra cost.

One off cost for set up is **£290 plus vat**. There is an annual charge for maintenance and looking after the PC in terms of legal and rules and regs requirements and website of **£190 plus vat**. (£140 for the first year as a new customer.) No hidden extra costs. RLS started in April this year and to date they have 25

All councillors agreed they had NO OBJECTION to the application and all agreed it was an excellent renovation.

17. To discuss any correspondence

Planning application. An email had been received on 19/8/2025 from Jamie and Lisa Tubby regarding their planning application on Bell Lane as they were not able to attend this meeting. (See Agenda item 16.1) This application was not discussed at this meeting as a decision had already been made by Breckland Planning to refuse it.

As you are aware we have submitted two applications on the land, both unsuccessful. The first one is a blessing as it was too big and we are glad this didn't go ahead. We adapted it to make it a much smaller build and set it back further and removed the equestrian use, hoping for a better outcome, however this was dismissed too. We really want to get across what we would like and work with the village and parish if possible and are absolutely open to compromise and adaptations to hopefully achieve our dream of a family, forever home to raise our children. We were advised in the early days to put in a call for sites, not knowing what it really meant so there has been confusion as to what we actually want.

Since we have removed the call for sites and we purely want to do one self build home as believe that's what is being encouraged in the planning world.

I am a builder which I know panics the residents, who then assume we will develop on the land, but please be assured this is not what we want and we'd happily have a clause in any plans to stop this as we just want one forever home, that I can build for my family but we just can't afford to buy a property that suits our needs. Property with land for horses is just crazy money as you can imagine.

I believe there have been queries as to why the equestrian use was removed on the second application. We cannot have our horses on the land without living there so a house is our foremost priority and the horses can then be in Paddocks and stables or shelters could follow. We have 2 horses and our daughter has 2 ponies. The land would mainly be post and railed paddocks with horses in and a property wherever

we'd be allowed it. The land would be private use just for our own horses and absolutely no business. Again, we would be happy for a clause in for this. We know there was a lot of panic about this initially and we can't stress enough, it's all for our own use. It has been absolutely heartbreaking reading the comments and going through this process and we really would love to work with you to try and achieve our dream and show our children that if you work hard, you can achieve things. If changing the style or the placing of the property so that the view isn't impacted would help in anyway we are absolutely open to options. As active members of the area already, having lived in neighbouring Griston all of our lives and our children attending the Gt Ellingham village school federation we would Love to be part of Rocklands community. If I or we can use our skills to help the village in any way we possibly can we would be very keen to do this. We would so appreciate and be forever grateful for your support.

Kemp Meadow. Cllr. Harrison had been contacted by Mr. Bocko who was looking to buy a house in Kemp Meadow. Mr Bocko had noticed concerns raised in the minutes regarding this development. Cllr. Harrison referred Mr Bocko to all information that was already in the public domain, PC website and minutes going back to 2017 and links to Breckland Planning website. Post meeting note: Mr Bocko's purchase has fallen through.

Magpie Lane. Cllr. Buckland had received an email from a resident who reported that a footpath was impossible to get through without walking on the farmers' fields. Clarification of which footpath was received. Footpath runs parallel with Magpie Lane. Entrance: 52.530188, 0.928067. Other entrance: 52.5285218, 0.9138410. Resident asked if OS maps could be updated as it says permission unknown. Cllr. Harrison said this is a Public Right of Way (PROW) and is not owned by the Parish Council, but by Norfolk County Council (NCC). NCC will be informed it needs cutting.
