# 1. To consider accepting apologies for absence

#### 5. To adjourn the meeting for public participation

# 6. To agree 2014 Donations to churches and other organisations

After some discussion it was decided that the donations to churches and other organisations in the village would be the same as last year. It was agreed that the churches should continue to be supported. Cllr. Steel mentioned that £700 raised from the Halloween quiz had been distributed to various groups within the community recently.

# 7. To discuss NCC grants for Local Highway Improvements

Although £200,000 was available in grant money from Norfolk County Council, the Parish Council would still have to find 50% of the total spend. No areas for improvement were identified that the Parish could afford. Flashing speed signs were discussed. It was thought Great Ellingham's sign had cost  $\sim$ £7000. NCC had quoted between £2,600 and £4000. Would be nice to have one on the main road or even better, in The Street. It was agreed that the cost was prohibitive.

# 10.3 New applications since last meeting

3AG/2014/0019/AG Bidmead/Tuppins Farm/ Extension to existing agri building - (53) (Note: This is NOT a planning application BUT a consultation to confirm building requested is reasonably necessary for the purposes of agriculture within the holding. There is 'intensive' cattle farming at Tuppins Farm. The hedges have been taken out and the neighbours are still complaining.

**3PL/2014/1017/F Batch/**Holly Cottage, Chapel Street/Minor alterations - (54) (Note: This is a minor material amendment to 3PL/2012/1057/F originally REFUSED) (Note: PERMISSION already granted - See above).

3PL/2014/1050/F Colchester/Cottage Farm, Bell Road/Ground solar array - (55) 20/11 Rocklands Parish Council has no grounds for objection to the solar array but would comment on the planning website as they would like the following points taken into consideration. Hedging to hide the installation should be fast growing and must be high enough and thick enough to completely hide the array from view. Construction traffic. Rocklands PC understand that the installation will take ~5 weeks and would ask that a sign is erected at Chapel Street saying that construction traffic is NOT to use this route to Cottage Farm, but instead should use the Scoulton Road. A concern was raised that agreeing to this application could open the floodgates in terms of other solar arrays in the area.

#### 11 To update on the Defibrillator

The Clerk had been waiting for the Co-op's Property department to finalise a 'release of equipment' letter to allow the equipment (defibrillator and cabinet) to be **donated** to Rocklands Parish Council. This letter finally arrived on the morning of this meeting. A representative from the Co-op will now arrange to deliver the unit to Rocklands for their own installation at the Village Hall. The Clerk knows a company that runs defibrillator training courses and they would be willing to arrange an awareness session at the Village Hall if required.

#### 12 To update on Village Shop and Post Office (RS).

There was good news that the shop had retained the Lottery. The Parish Council had sent a letter of support for the shop. Cllr. Steel thanked Cllrs. Bill Smith and Cliff Jordan, George Freeman (MP), Baroness Sheppard and the Post Office Staff as all had written letters of support which had almost certainly helped to sway decisions. The situation wouldn't have happened if Camelot had taken the 10

weeks with no sales whilst the shop was closed for refurbishment etc. Lottery sales had been constantly maintained since the decision.

**Halloween celebrations** at the Shop had gone well. A large number of houses in the village had put up Halloween displays. There was an under 10s ghost walk attended by 100 children (and some adults). The adult ghost walk was amazing, round the village and ending up at the pub. Shop takings were £1300 and the cafe took a further £100.

**Turn the village purple**. An event to fundraise for pancreatic cancer. The Shop stayed open until 8 o'clock. The pub made purple cocktails. The Shop sold purple cakes. Houses were lit by purple bulbs. For 2015. Earlier planning and better advertising.

## 14 To receive update on Playing Fields and Deed of Dedication

Playing Fields (DH) A ball stop net had been installed and was now operational. ALL youth football was being played at Rocklands (Not all Rocklands children). Where things have been moved around, some flint had been brought to the surface causing danger to users. Mayflies had to be treated as they were damaging the grass. Still having problems with rabbits.

Deed of Dedication. A draft 'Certificate of Title' and a draft 'Declaration by RPC' has been received from our solicitors. The Declaration was circulated to all councillors for checking and Cllr. Howie confirmed that paragraph 3 needed amending and one paragraph was wrong. A revised declaration has just been received and needs signing. Land Registry fees are now payable (£279). The solicitor costs (£360) will be paid once the matter is completely finished.

ACTION Clerk to write to Playing Fields summarising costs incurred.

Further grants. It was suggested that a letter be written to the Village Hall and Playing Fields to say that grant payments should not be arranged to go through the Parish Council bank account unless prepared to pay fees/costs/additional expenses.

#### 15 To receive update on Highways

Two lights that were out were repaired very quickly. Bamboo is still coming through the tarmac at Rigeons. Thieves Lane getting bad and can't see when pulling out. Many junctions are bad. It was commented that cutting round the pond was dangerous as the man hole covers were exposed. Cllr, Howie has spoken to Paul Sellick at the Breckland council and he is well aware of all of the problems.

No issues with flooding. Flash floods have continued to clear.

#### 18 AOB - To receive items for next agenda

New look website. Councillors agreed to look at the website and feedback to Ian Scholes. Chapel Green. Chris Sharpe keen to be fully involved so maintenance problem sorted. Chris will maintain a natural look.

Register of Electors. Although register had been requested, it had never been received. Fields in Trust. Centenary Fields programme. FIT increased membership from £25 to £50 so agreed not to renew.

Fish and Chip van. The owner is not responding to request to reinstate the service at the Village Hall.
